## THELMA BOAC'S BIO

Mrs. Thelma Boac has been a resident of the Berryessa area for nearly fifty years. She first moved to the Santa Clara Valley after graduating from San Francisco State University in 1972 with a degree in Music and Spanish. She also earned her California Secondary Teaching Credential from San Francisco State University a year later. She earned her Master's Degree and Administrative Credential from San Jose State University.

A life-long educator, Thelma began her 28-year teaching career in the Cupertino School District before moving to Sunnyvale School District as a Spanish Teacher/Resource Specialist at Sunnyvale High School. She then moved to the East Side Union High School District in San Jose where she taught for 26 years in the classroom. Among the many subjects, Thelma taught Spanish, World History and various levels of English as a Second Language. She also wore many hats serving her students in the capacity of mentor and club advisor for the Filipino Mabuhay Club, Asian Student Union and Filipino Student Union.

Beyond the classroom Thelma served as a Literacy Coach, Department Head, ELL Summer School Assessment Coordinator and on the District Team who assisted in yearly Compliance Reviews and the Office of Civil Rights District Assessment Team.

She was promoted to the position of Villa Principal at Independence High School in 2001 were she was part of the management staff that supervised 4,200 students and over 270 staff members. Independence High School was the largest High School in Santa Clara County at the time. Thelma's role was to supervise the 9th Grade program which included 1,200 students and thirty-five certificated staff, counselors and community liaisons.

Her success as a Villa Principal landed her an appointment to the Principalship at Silver Creek High School. Thelma was quoted "My years as principal of Silver Creek High School were the best years of my professional career". Thelma retired from the East Side Union School District in 2011. Upon retirement she was recruited by the San Jose State University, The National Hispanic University and Santa Clara County of Education to train, supervise and coach new teachers and newly appointed principals.

As Thelma's professional career was blossoming, she was also very active in her local community. She is a long-time member of the Berryessa Citizens Advisory Council. She has been very active at St. Victor's Parish as the Lector and Eucharistic Minister. She can be found most Sundays reciting the Sunday Readings at St. Victor's. She is a volunteer Teacher at the Northside Community Center. She has served as the President of the Filipino American Movement in Education and on the Board of the California Association of Filipino Educators.

Thelma, an advocate for educators of color, has served as president of the Silicon Valley Filipino American Movement in Education (FAME). The group influenced the East Side Union School District in the recruitment of teachers from the Philippines to mirror the student population in the district in the content areas of Math, Science and Special Education.

She has been the recipient of many state, city, and local awards. Among the most noted are the San Jose Local Hero Award by State Assemblyman Bob Wieckowski and again by State Assemblyman Kansen Chu, the Kalayaan Hero Recognition by the Philippine Consul General, and the Distinguished Women Awards by the Ivy Rose Community Foundation, and members of the Eta Rho Omega Chapter of Alpha Kappa Alpha Sorority. In 2007 Thelma was recognized by the Filipina Women's Network as one of the 100 most influential women in the United States. This association has afforded her to be a role model and influencer on the national and international level. She has been a guest speaker at the several of their international events along with being published in two of their books **Dis-Rupt** and **Dis-Rupt 2.0**.

In 2012, Thelma's passion for education took a turn toward governance and educational policy as she applied for the Berryessa Union School District vacant trustee seat. She was appointed to the Board of Trustees to complete the remaining two years of a term that had been vacated. Since then, she has been re-elected twice to the Berryessa Union Board of Trustees and is the current Board President.

Thelma has worn many hats but the ones she covets most is that of wife to her husband Dani and mother to her son and daughter, and grandmother to her four grandchildren. It is with great pride and distinction that we honor and celebrate this local hero as the Berryessa Community's Citizen of the Year.
